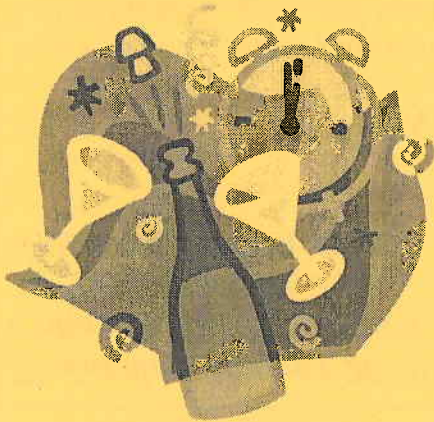
- > Protect Specific Plans throughout the City of Los Angeles by changing the implementing ordinance of SB1818.

Protecting The Community From Overdevelopment

The Valley Village Specific Plan

- Limits certain types of commercial enterprises;
- Regulates the placement of balconies and rooftop installations on apartment buildings;
- Requires appropriate landscaping.
- Mandates no new commercial buildings higher than 36 feet, and no homes higher than 30 feet.

FEATURED SPEAKER City Councilmember Paul Kerkorian

Paul Kerkorian, a third generation resident, was born and raised in the San Fernando Valley. Paul attended LAUSD schools, graduated from USC and earned a law degree from U.C. Berkeley. Paul was elected to the Burbank School Board and then the California State Legislature in 2006. He has served on the Los Angeles City Ethics Commission, chaired the Assembly Select Committee on Renewable Energy and authored the first incentive in California history to fight runaway film production.

Paul was elected on December 8th to represent Council District 2 on the Los Angeles City Council. Half of Valley Village is in Council District 2.
